



### N-Channel QFET® MOSFET 60 V, 30 A, 40 mΩ


#### Description

This N-Channel enhancement mode power MOSFET is produced using Fairchild Semiconductor's proprietary planar stripe and DMOS technology. This advanced MOSFET technology has been especially tailored to reduce on-state resistance, and to provide superior switching performance and high avalanche energy strength. These devices are suitable for switched mode power supplies, audio amplifier, DC motor control, and variable switching power applications.




Figure 1. On-Region Characteristics




Figure 2. Transfer Characteristics




Figure 3. On-Resistance Variation vs. Drain Current and Gate Voltage




Figure 4. Body Diode Forward Voltage Variation vs. Source Current and Temperature




Figure 5. Capacitance Characteristics






Figure 6. Gate Charge Characteristics




**Figure 7. Breakdown Voltage Variation vs. Temperature**




**Figure 8. On-Resistance Variation vs. Temperature**

Figure 12. Gate Charge Test Circuit & Waveform




Figure 13. Resistive Switching Test Circuit & Waveforms




Figure 14. Unclamped Inductive Switching Test Circuit & Waveforms


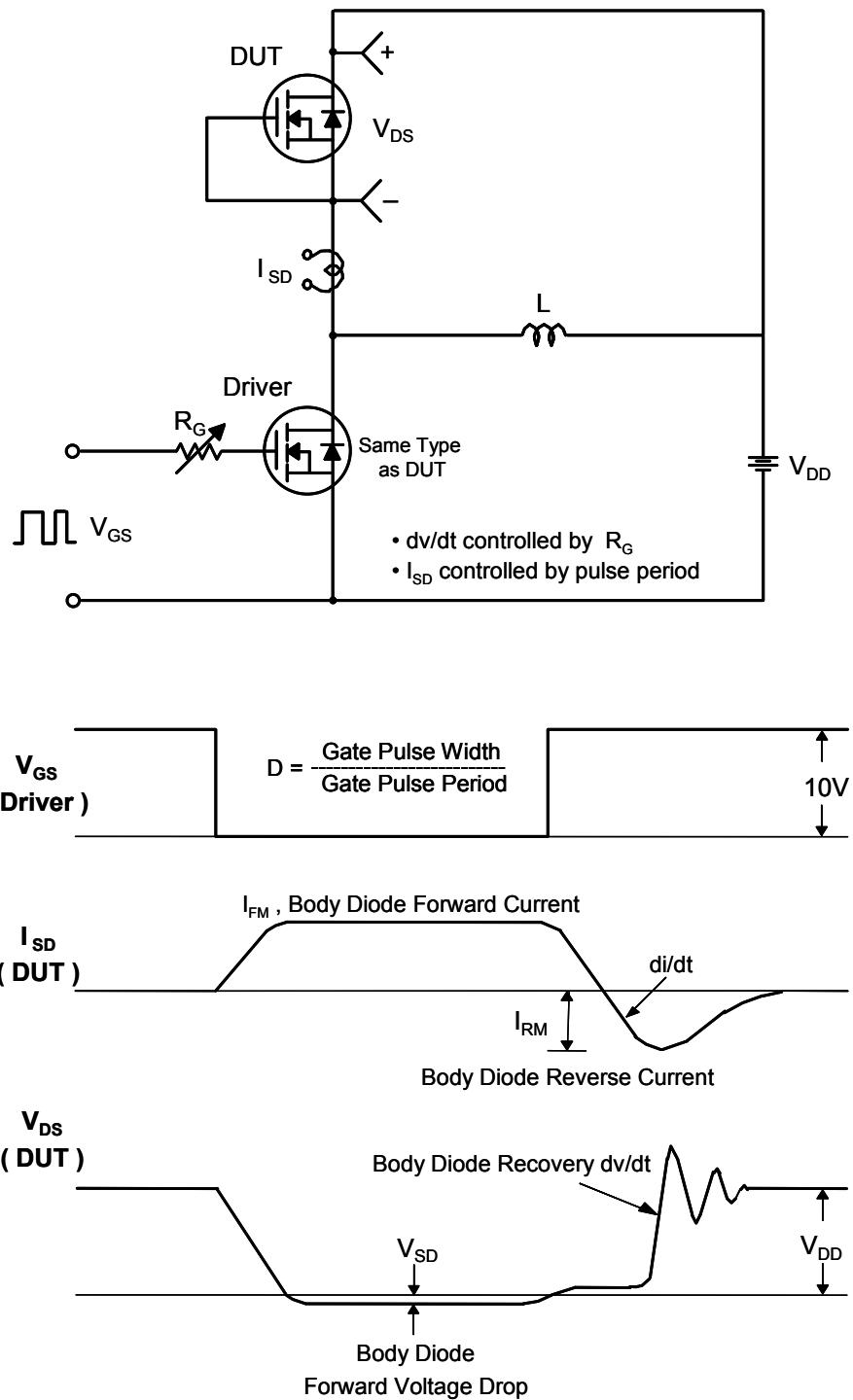



Figure 15. Peak Diode Recovery dv/dt Test Circuit &amp; Waveforms
